DEAR PRESBYTERIANS,

It's August Ya'll! One of my favorite things to do this summer has been to go to the pool at our local Ransburg YMCA. I go with my towel, book, sunscreen and one of those flowery swim caps, made famous by old ladies everywhere. One thing I noticed pretty quickly at the pool is how often the lifeguards were blowing their whistles, especially in the area where I preferred to sit and read! Thus, disturbing my peaceful sunny learning time. My first thought was something like "wow, why do so many people keep breaking the rules?!" Because the idea of someone blowing a whistle and pointing at me in front of everyone for doing something wrong is an actual nightmare. Did they not care about the rules? Did they enjoy making the poor lifeguards keep blowing their whistles over and over again? Were they engaged in some kind of rebel dare contest of who could get whistled at the most without getting asked to leave? I needed more information. Here is what I observed.

First, I realized that the part of the pool I like to go to is considered the deep end. In order to keep everyone safe, if you want to be in the deep end of the pool a person must either be tall enough to comfortably stand at the deepest depth and still have their head above the water OR they must be able to pass a swim test that is administered by a lifeguard. Once they pass the test, they get a wristband so all the lifeguards know they can safely swim in deep water. I have no objections to these rules, they seem reasonable and important for everyone's safety. There is plenty of space in the shallower waters for anyone unable to be in the deep-end. And there's nothing special they are missing out on in the deep end like a slide or diving board, which I would really enjoy and would have thought about breaking the rules to use. So, you may ask "Then Mo, why were so many people breaking the rules!?" Well, I'll tell you. People were breaking the deep-end rules because they didn't know they existed! If they were posted anywhere, I couldn't see them, at least not near the actual deep end. Yes, there is a rope between the shallow end and the deep end but unless you know that the rope is in fact a magical barrier for which the right to enter you must bear proof, it just looks like a rope. Kind of like the old "smoking and non-smoking sections in restaurants. Sure, you can keep the kids from sitting right next to a chain smoker as a rule, but I don't think the smoke, much less lung cancer knows or was ever deterred by a rail separating the two designated

Again, I have no issues with the rules themselves if they are fair and make sense. I do have an issue with unexpressed rules and expectations. For one, I'm sure the lifeguards don't enjoy calling people out for breaking rules they never knew existed, and I'm sure it spoils the fun of kids just trying to enjoy their time at the pool. Yes, there will always be a few people looking to bend or break the rules, but for the most part, the people who got the whistle genuinely had no idea they were doing anything wrong. How could they if they never were told? You shouldn't be labeled a cheat if you don't know there are supposed to be rules to the game in the first place.

Similarly, in any society, community, congregation, and relationship, we need to keep in mind that no one is in fact a mind reader. If we don't share our expectations and needs with one another how can they ever be met? This is when there are bound to be problems. If we are all going to run around blowing our whistles at each other for the expectations, we have made up in our heads we are in trouble. It's a recipe for feeling hurt, shame or resentment especially if someone claims we did something wrong but never communicated the needs in the first place. Churches are places of great traditions, but sometimes those traditions act more like unwritten rules and unsaid expectations, and when that happens, we end up with a lot of whistleblowing, fun-ruining, and destroying of peaceful learning time!

Last week, I met with one of the Y staff members to offer some unsolicited advice on my observations (he took it better than I normally do) I recommended they post the guidelines and how to take a swim test prominently by the deep end of not all around it. That way swimmers could understand if and how to use that area. My hope is that would take some of the pressure off the poor lifeguards to always be the funruining literal whistle-blowers as well as keeping people from feeling embarrassed or ashamed when they get called out for doing something they didn't know was wrong.

I'm not sure if they will take my advice, maybe by the time this newsletter comes out we'll have a system in place that is clear and keeps everyone swimming safely, or maybe nothing will change, and I'll just need to invest in so noise canceling headphones. But it's got me all riled up about unwritten rules and unexpressed expectations in life and sometimes in faith communities and how we can avoid it with fair expectations and clear communication. Maybe you've experienced something similar. Thank you for coming to my "TED Talk" and have a great August!

The sunburn doesn't sting as bad when you deliver the vegetables from the garden to someone that has been displaced by the tornado. You don't notice the body aches so much when you are celebrating a birthday or going on the daily trip to Walmart to get matching t-shirts or more snacks. Sharing a room with other people doesn't seem so bad after you've shared Karaoke with them, and everyone sang along to the best version of Don't Stop Believing that you've ever heard.

So, yeah, going on a mission trip is hard, but if it were easy, it wouldn't have such an impact on our hearts.
